# 5. Finance & Budget Report

- 1. Mr. Gomes updated the Board on the status of surface lot 1212 Main St. (parcel C) He informed the Board that HPA will no longer have use of this surface lot for parking cars as of March 2020. Mr. Gomes stated there will be a slight loss of revenue with this loss of 1212 Main St. surface lot. Accommodations are being made to 58 Chapel St., San Juan and Ann Uccello surface parking lots to accommodate the Yard Goats game day parking. Mr. Gomes discussed he will be conducting a parking study throughout the City to identify new sources of revenue for HPA.
- 2. Mr. Michalik Interim Finance Director reported on the 2020 2021 FY budget (See Finance report for details)
- **3.** Discussion HPA 401A plan, Mr. Gomes presented the Board with a memo recommending this year's contribution be increased to 10%.
