

# Approved Minutes Tuesday, December 15, 2020 - 5:00 p.m. Regular Board Meeting of the Board-Hartford Parking Authority 11 Asylum Street, Hartford, CT 06103

- 1. <u>Call to Order</u> Mr. Sager called the December 15, 2020 Regular Board Meeting of the Hartford Parking Authority ("Authority" or "HPA") to order at 5:15p.m.
- 2. <u>Roll Call of Commissioners</u> The Secretary, Mr. Sheiber conducted roll call, and announced there was a quorum present.
- 3. <u>Commissioner's Comments</u> Mr. Sager mentioned that he had seen Mr. Breetz (former Chair of the Hartford Parking Authority) and that they had a nice conversation about HPA. Mr. Sager wished all present, a happy and safe holiday season. Mr. Sager had some questions about the Board member election process for Mr. Del Visco. Mr. Gomes asked Mr. Sheiber to read a paragraph from the HPA bylaws pertaining to the HPA election process. Mr. Sager then turned the meeting over to Mr. Bercowetz to start the election process.

## 2. Finance Committee - Mr. Bercowetz

Mr. Bercowetz asked Mr. Gomes to give the financial update to the Board. Mr. Gomes gave and overview and update of the current budget noting that on street citations and citation collections remain steady. MAT Garage and parking lot revenue remain low do the pandemic. Mr. Torres expressed concern about snow ban tickets in the neighborhoods for those that maybe unemployed. Mr. Gomes informed the Board that HPA along with Corporate Counsel have been working to reduce penalties on citations whenever possible. He noted outstanding citation as far back as 2012 are getting paid.

Mr. Sager reported the citation issuance numbers for the neighborhoods remains strong and the cleanup of old outstanding citations is progressing well. HPA is working with the developer of the 1212 Main St. property on an agreement to use the 58 Chapel St. parking lot for a staging area during the project. 4G upgrades to the meters continues to move forward. Mr. Sager informed the Board that HPA has agreed to allow the Hartford Guides to relocate to the MAT garage office in support of conducting HPA business only.
