# 5. Approval to the Minutes for the Regular Board Meeting on June 22, 2021

# 2. <u>Finance Committee</u> - Mr. Bercowetz

Mr. Bercowetz gave an overview of the June finance report. Mr. Bercowetz stated FY 2020/2021 ended on a strong note which should help moving forward in the new FY 2021/2022.

Mr. Michalik gave a detailed update on the summary of operations report. Mr. Sager had some questions on the new fiscal year's budget starting points.

Mr. Michalik stated that HPA's budget will remain flat for the first 6 months of the new FY and then increase in increments for the second half of the FY.

Mr. Sager asked if Mr. Gomes had any new information on when some of the bigger corporations might be returning to the office. Mr. Gomes stated he had no specific information at this time but feels that most will start to return in September through November.

Mr. Torres asked with entertainment returning to the city in the fall, would that add to the overall budget? Mr. Gomes stated it would have very little effect on the budget do to the fact most entertainment is on the weekends when parking is free.

Mr. Sager discussed the potential loss next spring of the 58 Chapel St parking lot to development and the parking problems this could have for the Yard Goats.

He gave the board members an overview on new properties and building projects HPA is working on, along with the City and members of the business community.
