# 2. Finance Committee - Mr. Bercowetz

Mr. Bercowetz stated the overall budget is tracking higher than expected. Mr. Michalik cautioned that expenses will also track higher in the new year.

Operating income compared to the budget is running favorable. Revenues compared to the budget is running favorable. Expenses compared to the budget are unfavorable.

MAT garage continues to outpace the budget. Meter revenue continues ahead of budget.

Citation revenue is off 5.6% from last year's average. Parking enforcement operating expenses are over budget.

Mr. Sager discussed an overview of the property management report. The collection rate was down in November compared to October. Booting was down for November as well as tickets paid. There were no changes with the surface lots.

No parking signs were established around South Park (Main and Park St.) This was requested by the Mayor's Office. Republic Continues to struggle with increasing ambassador head count.

Financial discussions have begun with Martin Guay, Vice President, Business Development Stanley Works on the development of the Parkville Garage.
