<u>Approval of Meeting Minutes for the Regular Board Meeting on November 22, 2022</u>- Mr. Sager polled Commissioners for correction to the minutes. Mr Del Visco noted two corrections were required that pertained to the executive session section. Mr Del Visco outlined the corrections needed and a move to approve the minutes as amended was made by Mr Sager, Seconded by Mr. Bercowetz.

REPORTS AND ACTION ITEMS

Personnel Committee – Mr. Torres,

Mr. Torres commented that after numerous interviews, Mr Gomes has hired a Director of Operations Jill Turlo, and a Director of Strategic Growth Kenny Gonzalez.

Mr. Gomes added that Jill was a VP Operations with her current position. That she was posed, confident and very well rounded. Kenny manages all CRDA Hartford CT facilities working for Propark and has years of experience with LAZ, and his history will help in our strategic growth, well spoken and knowledgeable.



Mr. Michalik added that they were an extremely impressive pool of candidate, but these two were just stellar, well spoken, experienced.

Finance Committee - Mr. Bercowetz

About \$500K over budget, 47% ahead of budget. Next year we will adjust to reflect current pace, and that next year's budget is due earlier than in previous year.

Mr. Gomes stated that he will work with commissioners to get agreement prior to our next Special meeting, sometime around the 10th.

Mr. Sager questioned the numbers Rensselaer numbers as being less than expected, but after discussions. Around actual cost to HPA, the BOE agreement and HPA's current Rensselaer agreement understood that we are flat to budget as expected.

Mr. Bercowetz motioned to accept the November budget report, seconded by Mr. Sager

Property Management Committee- Mr. Sager

Mr. sager, fairly unexciting. Numbers are good, lower paid numbers given the time of year. Please with numbers. No change to other surface lots.

High street lot will be leveled and ready for Spring.

Library Garage work will no go forward because City (DPW) is assuming all work HPA was planning on performing. Mr. Gomes offered the possibly entertaining the notion of shifting the approved founds to the MAT garage to allow further work to be performed given the library lot situation. Mr. Del Visco mentioned that a simple resolution to shift the funds would suffice.

Mr Sager questioned the holding cost associated with Rensselaer and if there were levers in the contract that would allow HPA to move away if needed. After a lengthy dialogue which included using the lot during the upcoming Yard goat season it was decided that maintaining the lot given the uncertainty of 58 Chapel Street lot made sense.



Bylaws and Revisions Committee – Ms. Chatfield

The 2023 board meeting calendar was discussed, with motion made to adjust the December 2023 meeting schedule from the 23rd to 12th. Calendar was approved with corrections.
